STUDENTS MAY REQUEST FROM THE DEAN FOR STUDENTS OR, DIRECTOR OF STUDENT SERVICES, A CHANGE IN AN EXAMINATION FROM ITS REGULARLY SCHEDULED TIME IF THEY HAVE TWO EXAMS IN ONE DAY OR FOUR EXAMS IN FOUR DAYS OR LESS. TAKE-HOME EXAMS LONGER THAN EIGHT HOURS ARE TO BE CONSIDERED TWO DIFFERENT EXAMS OVER TWO DAYS FOR PURPOSES OF THIS RULE. EIGHT-HOUR (OR LESS) TAKE-HOME EXAMS OVER ONE DAY WILL NOT BE CONSIDERED TO BE TWO EXAMS ON THAT DAY.

(TIMES: FOR EXAMS OVER 3 HOURS AND 15 MINUTES IN LENGTH, MORNING EXAMS START AT 8:00 A.M.; FOR EXAMS 3 HOURS AND 15 MINUTES OR LESS IN LENGTH, MORNING EXAMS START AT 9:00 A.M.; ALL AFTERNOON EXAMS START AT 1:00 P..M; ALL EVENING EXAMS START AT 6:00 PM). LAPTOP TAKERS MUST BEGIN SETTING UP 30 MINUTES PRIOR TO THE SCHEDULED START OF THE EXAM.
